## BOARDING CONTRACT

This agreement is entered into between DIA Park and Park and the owner/agent of the pet(s) indicated above.

1. All fees are due and payable at the conclusion of the boarding or upon demand. Non-payment fees when due or checks that bounce may leave the contracting party liable under applicable Colorado Lien Statutes. A fee of \$40.00 will be charged for returned checks. Should legal recourse be required for collection, damages shall include court costs and reasonable attorney's fees.
2. DIA Park and Bark shall provide medication and/or professional veterinary assistance to animals which become sick or injured while under the care of the kennel. Such fees that result will be the sole responsibility of the animal's owner. Upon notification of the owner (if possible) of illness/injury, Strasburg Veterinary Clinic or an after hours emergency veterinary clinic will be used.
3. DIA Park and Bark will not be liable for the injury, disease or death of any animal, if such conditions arise due to circumstances beyond its control. It is agreed the liability of the kennel shall not, in any event, exceed \$200.00 per pet. The Colorado Department of Agriculture requires us to notify you that in the unfortunate case of an animal death in our care, your pet will be transported to the Strasburg Veterinary Clinic.
4. Parties contracting herewith agree to inform DIA Park and Bark of any dangerous behavioral tendencies of their animals, any illness or disease that the animal may have, and whether the animal is currently in GESTATION, ESTURUS, or INTACT.
5. All pets left for 14 days without being picked-up and no notification will be considered abandoned and DIA Park and Bark reserves the right to sell, place or dispose of the animal. We will make every effort to contact the owner or alternate guardian prior to any action.
6. Boarding Charges are based on the following:  
We charge for the first day regardless of what time the animal arrives at the kennel. Last day will not be charged, if pets are picked up before noon, but a full day will be charged after that time. Pick-up and drop-off by APPOINTMENT ONLY. There will be a \$10.00 charge for after hours pick-up or drop-off.
7. If paying by credit card, client will need to complete a Credit Card Authorization Agreement and will be charged a transaction fee of an additional 1.58% of the total invoiced amount.
8. The undersigned read and understood the above, including the charges and any veterinary fees that might be incurred.
